

- Every candidate is required to furnish an affidavit duly completed in all the aspects along with the Nomination Paper to the effect that he/she does not have any previous criminal record and has not been subjected to any disciplinary action by the College/University. **Further, the contestants should not have failed in the preceding academic year (s) and/or re-admitted in the current year.**
