Union of India & Ors (Defacement Case)", The Delhi Prevention of Defacement of Property Act, 2007 and NGT orders from University official website i.e. www.du.ac.in - DUSU Elections 2023-24 and the Colleges website respectively for all the posts.
- 2. The nomination should be filed only on this form. Nomination filed on any other form shall be considered invalid.
- 3. The nomination paper should be complete in all respect. No column should be left blank. Incomplete form shall be rejected.
- 4. The filled up nomination paper duly verified by the Principal/Head of the Department/Institution should be deposited in the sealed box kept in the Office of the Chief Election Officer on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. on Tuesday, the 12th September, 2023 alongwith a Demand Draft of Rs. 500/- from any nationalized Bank in favour of the Treasurer, Delhi University Students' Union.
- 5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College/Department/Institution Identity Card. No withdrawal shall be allowed after 12.00 noon on Wednesday, the 13th September, 2023
