The filled up nomination paper duly verified by the Principal/Head of the Department/Institution should be deposited in the sealed box kept in the Office of the Chief Election Officer on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. on Tuesday, the 12th September, 2023 alongwith a Demand Draft of Rs. 500/- from any nationalized Bank in favour of the Treasurer, Delhi University Students' Union.
- Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College/Department/Institution Identity Card. No withdrawal shall be allowed after 12.00 noon on Wednesday, the 13th September, 2023
