3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. 4. **The total quote (TBL+ Artist Fees) should be inclusive of GST. [TBL= Travel, Boarding and Lodging]**
5. **Scanned copy of PAN Card in the name of firm/proprietor shall be uploaded.**
6. **Scanned copy of GSTN certificate of the firm/proprietor shall be uploaded.**
7. **If the Vendor has any GST exemption certificate, it shall be uploaded.**
8. **Scanned copy of any previous experience/feedback from any government institution or private institutions relating to the organization of an event of a similar scale.**
9. **Scanned copy of an agreement of adherence to T & C shall be uploaded.**
