

Dr. Neha Singhal, *(Convener, Webinar Committee)* initiated the session by giving a brief overview of the topic and its stark relevance in our lives. She was then followed by Dr. Mamta Arora, *Teacher-in-Charge,* who graciously proposed the welcome note on behalf of the commerce department. Then Dr. Neha Singhal, gave the opening remarks and enlightened the inquisitiveness of the audience by introducing the prominent speakers with an insightful and







This part was rich with interesting facts and figured which captivated the audience, by quoting world's future projection of the number of cyber-crimes and ascertaining the global cybercrime damage costs at around \$6 Trillion USD per year. He also mentioned about the recent WhatsApp privacy issue and gave us interesting insights about the same before passing over the seminar to Ms. Manisha Aswal. She talked about the prevalent Cyber crimes in social media, with an interesting twist to learning cyber laws by giving real life examples and connecting





them to set IT laws in order to show its practical application in real-life. Some cases which she took us was the "Bois Locker room" (Cyber Obscenity), "Nidhi Razdan Harvard Job Fraud" (Phishing) etc. After Manisha ma'am gave us a riveting insight into the liability of individuals and owners on an online intermediary platform, the audience was treated to few real-life cases of cyber-crimes, which Mr. Shubham Jain had encountered in his profession. The non-fictional outlook into cyber-crimes was of great example and lesson on the topic. The practical application and usage of digital signatures, as later shown by our distinguished speaker, Mr. Shubham Jain, was the cherry on top of an amazing and mind-numbing session.
