Term of the student members/representatives to the ICC

Under regular circumstances, the term of the Students' Representatives to the ICC is for a period of one year or till the result of the subsequent election is declared in the category or till he/she is a bonafide student of that course for which he/she was admitted, whichever is earlier, provided that.

- The students' representatives shall not represent in the ICC from the end of their examination 2. (in May) till the commencement of the subsequent academic session; and
- The Students' Representatives to the ICC shall, in no case, have a term beyond one year. 3.
- The members appointed from amongst the non-government organizations or associations shall be paid 4. such fee or allowances for holding the proceedings of the Internal Committee, by the Executive Authority as my be prescribed.
