EVENT REPORT

Workshop on "Financial Education for Young Citizens"

The Criteria 2 of IQAC cell of Sri Venkateswara College, University of Delhi organized a **10-hour financial training Workshop** in the college premises from 6th February 2023 till 11th February 2023 in collaboration with National Institute of Securities Market (NISM) and Kotak Securities. The guest speaker of this event was **Dr. Shikha Gupta**, Security Market Trainer of SEBI, NCDEX, NCFE, CDSL, ICAI, PFRDA, NISM and is authorized to conduct Investor Awareness Programs across India, with an experience of 14 years in education sector, currently working as associate professor at Lingaya's Lalita Devi Institute of Management and Sciences and has imparted financial literacy to more than 10,000 students and faculty across India.

Objective of the event:

- 1. Basics of Investment
- 2. Higher learning in Primary and Secondary Market
- 3. Precautions in Stock Market
- 4. Career Development in Financial Services Industry

The event was divided into 3 days as follows:

Day 1: 6th February 2023

Dr. Shikha Gupta began the session by defining the objective of the program to along with specifying the Program outline divided into 8 modules:

Module I: Importance of Investment

Module II: Financial Investment Opportunities

Module III: Process and Pre-requisites to invest in Securities Markets

Module IV: Investment in Primary Market

Module V: Investing in Secondary Market

Module VI: Introduction to Mutual Funds and ways to invest in them

Module VII: Precautions while Investing in Securities Markets

Module VIII: Career in Securities Market

Beginning with the Session I, Dr. Shikha Gupta gave insights on **Objectives of Investing to channelize** money into safer avenues, having ultimate objective of taking wise decisions in the securities market. The

speaker explained the concept of savings and investment through a real-life example of how students lack to identify expenses and channelize savings through their pocket money, which can be done through the concept of **SMART** (Specific, Measurable, Achievable, Realistic, Time bound) savings and **Expense budgeting** to track expenses, categorize spending and identify patterns of spending, to bifurcate needs and wants and control expenses based on priority and desire. She further explained the concept of **Inflation and Investment**. Investment is done to beat inflation, therefore aspects to be considered while investing are inflation, tax, cost of investment, brokerage and service charges, along with the **Three Pillars of Investing** i.e. Liquidity, higher returns, and safety of money. Further investments are often **goal based**, which can be short term goals (period of less than 1 year), mid-term goals (period of 3-5 years) such as buying a car, long term goals (period of more than 5 years) such as retirement plans. To calculate the time taken by the investment to double the principal amount, we were introduced to the concept of **Rule of 72**. She further explained how delay in investing can be costly through an example of children's education saving plan done by various parents. Another concept covered under the session was about **popular asset classes** including equity, fixed deposits, gold and property and identifying their risks and creating a **portfolio** for **risk diversification**. With this Module I and II were covered in the training on Day 1.





Day 2: 7th February 2023



The Day 2 of the training began with a brief revision of the modules covered on Day 1 and a pre-quiz was provided as a task to students. After the quiz, Dr. Shikha Gupta began with the Module III, explaining various investment opportunities and their pre- requisites. Students were introduced to various schemes available for investment such as small savings scheme, Public provident fund (PPF), etc. She explained various benefits of these schemes such as tax savings, low principal amount and lock in period. Various modes of Investment such as Direct Investment route and investment through Mutual funds route were discussed. Direct investment requires extensive time and research, proficiency of stock selection, brokerage cost and there is also a role of emotions while dealing with the stock market. One should follow simple rule while investing directly i.e. when the stock is underpriced, it is the right time to buy the stock and if one buys at highest maturity level, he/she is likely to bear loss. Investing through Mutual funds is easier and requires less knowledge than direct investing, it is beneficial for portfolio diversification, better liquidity and cost effectiveness. Further she taught about the Three I's of Securities Market i.e., Issuers, Intermediaries and Investors and their role in the market. She taught about the structure of Indian Securities Market and guided to research about companies through research papers, ROC filings, Industry reports, Credit Ratings, etc. to analyze the information and invest wisely. The students were then introduced the easiest way of applying for IPOs- Application Supported by Blocked Account (ASBA) under which the amount applied for IPO is blocked by the bank itself such that the interest through bank is still available to the investors. The process applying begins here. After the application has been accepted, price is discovered by the company along with a merchant banker then the securities are allotted to investors. Certain precautionary points were also discussed to In the session Module III and IV were covered, which was followed by a Q&A round; where students asked their doubts.

Day 3: 11th February 2023

Speaker of the session: Dr. Shikha Gupta

Coordinator: Mr. Aashish Jain

The Day 3 of the training began with a brief revision of the modules covered on Day 1 and Day 2. Thereafter, **Dr. Shikha Gupta** began with the **Module V: Investing in Secondary Market**, she explained the **functions and utilities** of the market, how it affects the economy along with the difference between primary and secondary market. **The process of investing in secondary market** involves **opening of 3 Accounts i.e. Bank Account, Trading Account, and Demat Account.** Further she covered types of orders, good practices for trading and explained the **due diligence** to be taken care of before investing in secondary market i.e. checking of the overall performance, dividend share etc. Sources to look upon due diligence are stock exchange websites, company websites, industry research, etc. Factors to look for metrics and due diligence are details of promoters, EPS ratio, Cash Flows etc. After that discussion, students were made

familiar with the process of placing an order in securities market, and definition of various product codes such as, MIS- Margin Intraday Square off, CIS- Cash and Carry etc. Further in Module VI, Dr. Shikha Gupta explained the importance of Risk-o-meter for Mutual Funds. Module VII covered the rights and responsibilities of an investor along with the SEBI's role in the market. Module VII covered various career opportunities available in financial services industry and skillset required to reach there. With this the training was completed and there was a brainstorming session where each student was encouraged to mention their key take-away from the training. This was followed by post quiz to assess the performance of students.
