## Memorandum of Understanding

This Memorandum of Understanding (MoU) is entered into between SRI VENKATESWARA COLLEGE of the University of Delhi, hereinafter called Sri Venkateswara College

AND

Institute of Nuclear Medicine and Allied Sciences, INMAS- DRDO situated at Brig. S. K. Mazumdar Marg, Delhi – 110054 hereinafter called INMAS.

Sharing a common desire to extend and strengthen the functional relationship between SRI VENKATESWARA COLLEGE and INMAS we the undersigned, mutually agree to share existing facilities and available expertise at our respective institutions viz. Sri Venkateswara College and INMAS by signing a MoU on 08/07/22 which reads as follows:

- The major objective is to establish a close linkage and functional coordination between Sri Venkateswara College and INMAS for mutual cooperation towards the advancement of knowledge of the employees, faculty and students of both the institutions and promote translational research to align with the National Education Policy 2020.
- Sri Venkateswara College and INMAS will both provide intellectual and infrastructure support for carrying out academic research in collaboration in the areas of mutual interest. A prior approval of each research activity under such collaboration is required from the competent authorities of both the organizations. Mutually approved research projects will be executed without any financial liabilities on each other for recurring expenses after assessing the priority. The outcomes of the studies in terms of research papers, patents, products, etc will be jointly shared by the individuals from both the organizations.
- Sri Venkateswara College and INMAS will encourage and provide facilities to scientists/ staff of INMAS and faculty members of Sri Venkateswara College, to explore and prepare joint proposals on thrust areas for funding. The technical activities and grant sharing between Sri Venkateswara College and INMAS shall be mutually agreed while submitting such proposals to funding agencies. The outcomes of the joint research in terms of research papers, patents products, etc will be jointly shared by individuals of both the organizations.
- In case of any academic lapses, Sri Venkateswara College will bring the matter to the notice of the Director, INMAS for initiating necessary action.

- Sri Venkateswara College will also confirm the status of a Visiting Faculty/Expert on INMAS scientist involved in common programmes depending upon their qualifications and designations.
- In line with National Education Policy 2020, Ph.D Students working at INMAS and Sri Venkateswara College will be allowed to carry out a part of their research work in various laboratories and facilities of INMAS and Sri Venkateswara College respectively or Vice-Versa. Both the Institutions will extend all necessary facilities consumable & expertise to the research students.
- The faculty and the students of the concerned departments of Sri Venkateswara College shall be enrolled as ad-hoc members of the library of the INMAS. While using INMAS Library facilities they shall be governed by the rules and regulations as operative in INMAS. Scientist and PhD students of INMAS shall likewise be given ad-hoc membership of the Sri Venkateswara College library.
- For the mutual benefit of the two Institutions i.e. INMAS and Sri Venkateswara College, there will be exchange of INMAS scientists and faculty members of the concerned departments of Sri Venkateswara College.
- INMAS and Sri Venkateswara College will work closely to generate appropriately trained manpower in the relevant areas through organization of formal academic curricula, symposia, short- term training courses etc.
- During review meetings, external guides of candidates working in INMAS shall be invited.
- It is agreed that the progress of this MoU shall be monitored by the Review Committee comprising of Principal, Sri Venkateswara College and Director, INMAS through periodic meetings.
- Sri Venkateswara College and INMAS may jointly organize Seminars /workshops/Conferences and short-term training programme on the topics of mutual interest.
- These arrangements shall be valid for a period of ten years commencing from the date of signing of this MoU and its continuance will be subject to review after the expiry of the agreed period of Ten years.
- Any disputes arising will be settled by mutual negotiation between the two parties.
- The MOU will be effective for a period of 10 years from the date of signature.



- Intellectual Property Rights ( IPR)

INMAS hereby agrees to assign the Intellectual Property Rights (IPR) to SRI VENKATESWARA COLLEGE for the joint work done in collaboration between SRI VENKATESWARA COLLEGE and INMAS. The right of first of filing will go to INMAS and SRI VENKATESWARA COLLEGE will be the joint intellectual partner of Intellectual Property Rights.

- CONFIDENTIALITY

SRI VENKATESWARA COLLEGE agrees to use all means to protect and maintain the confidentiality of INMAS confidential data and information acknowledged or received by SRI VENKATESWARA COLLEGE. INMAS by accepting the exclusive services from SRI VENKATESWARA COLLEGE (collectively the "Confidential Information") shall not disclose or transfer any Confidential Information to any third party as per agreement terms. Upon termination or expiration of this Agreement SRI VENKATESWARA COLLEGE shall return all documents, information any of such Confidential Information to INMAS, as notified. Both the parties shall abide strictly by the terms of confidentiality. This was agreed by both the parties that this agreement will be supported by a Non Disclosure Agreement between both the parties for a period of 10 years.
