MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSIDAD DE BURGOS, BURGOS, (ESPAÑA)

AND

SRI VENKATESWARA COLLEGE, UNIVERSITY OF DELHI (INDIA)

Prof. Manuel Pérez Mateos, Rector Magnífico, acting on behalf of the UNIVERSIDAD DE BURGOS by virtue of the faculties granted by article 20 of Organic Law 6/2001, 21st December, concerning Universities and articles 81 and 83 of the University of Burgos Statutes, approved by Agreement 76/2003, 26th December, of the Regional Government of Castile and Leon.

And

Prof. C. Sheela Reddy, Principal, acting on behalf of SRI VENKATESWARA COLLEGE, a constituent college under the University of Delhi by virtue of the faculties granted under section 2(f) and 12 (B) of the University Grants Commission Act, 1956, of the Ministry of Education, Government of India.

Universidad de Burgos and Sri Venkateswara College are hereinafter referred to collectively as the "Parties" and individually as the "Party."

Both parties recognize each other's legal capacity to sign the present Memorandum in name of the institutions which they represent and

DECLARE

First.- That Sri Venkateswara College, is a constituent College of the University of Delhi, India, managed by the Tirumala Tirupati Devasthanams. The College, accredited A + Grade by NAAC in 2022 and ranked #11 by NIRF, Ministry of Education, Government of India in 2021, offers undergraduate and postgraduate programmes in Humanities, Science and Commerce. Sri Venkateswara College proudly promotes and preserves diversity and inclusivity through its 4500 plus student strength, and its large teaching and non-teaching faculty. With its integrated teaching and research approach that maximizes specializations, interdisciplinary perspectives, and state-of-the-art facilities, the college strives to create a stimulating atmosphere for learning, intellectual growth, logical thinking and high standards of ethical and environmental awareness along with academic excellence.

Second.- That Universidad de Burgos is a body governed by public law endowed with legal personality and autonomy, as set out in article 1 of its Statutes. Among its general functions, the Universidad de Burgos has those corresponding to preparation for carrying on professional activities that require the use of knowledge and scientific methods, and the spread, assessment and transfer of knowledge at the service of culture and economic development.

Third.- That, with the aim in view of establishing relationships of cooperation between the two institutions, especially to develop academic and cultural exchanges through mutual assistance in the areas of education, research and others, they agree to the following



CLAUSES

FIRST- OBJECTIVE

The purpose of the present Memorandum of Understanding is to establish the framework for future teaching, scientific, technological and cultural collaboration between the Universidad de Burgos and Sri Venkateswara College for the accomplishment of several activities.

SECOND - PRIORITY AREAS

In order to fulfil the above mentioned objectives, both parties will organize joint programs in physical/virtual modes, particularly those related to the following priority areas including, but not restricted to — Cultural Diversity, Education in a Globalising World, Gender Studies, Indian Literature, Anthropocene and Climate Change through the following:

Promotion of educational visits and exchanges to explore cooperation opportunities in international education and exchange programs.

Development of partnership programs driven by common interests.

THIRD - SPECIFIC AGREEMENTS

The specific aspects of programs to be undertaken will be developed subsequently through the execution of Specific Agreements.

These Agreements specific to each priority area will be incorporated as signed by the parties.

The present Memorandum entails no financial liability on any party.

FOURTH- DURATION

This Memorandum shall have a duration of **Four years** from the date of signing and shall be automatically extended for annual additional period (until four additional years), as long as either party does not decide to terminate the memorandum; where in such case, it shall submit a written notice three months prior to the date of withdrawal

FIFTH- STEERING COMMITTEE

A Steering Committee will be constituted by one representative of each party.

The representative of Universidad de Burgos will be: Illeana María Greca Dufranc, Vice-Chancellor for Internationalization, Mobility and Cooperation (sec.internacionalizacion@ubu.es).

The representative of Sri Venkateswara College will be: Dr Rina Ramdev, Associate Professor, Department of English (rinaramdev@svc.ac.in)

SIXTH - AMENDMENTS AND TERMINATION

All modifications to this Memorandum will require an amendment duly signed by each party unless otherwise agreed by the Steering Committee.

In the case that there were Specific Agreements in force when the present Memorandum is terminated they will continue to be in full force and effect until the completion of the specific activities.



SEVENTH- SETTLEMENT OF DISPUTES

The parties agree to submit to the representatives appointed according to the sixth clause all disputes that may arise concerning the interpretation, development, modification, resolution or effects that could derive from the application of the present Memorandum of Understanding as well as from the Specific Agreement that might be derived thereof.
