It is pertinent to mention here that as per university rules vide University of Delhi Ordinance VIII (E) 2 (b) and (c) on Internal Assessment Scheme, calculation of the attendance of every student in each paper (lectures and tutorials), conversion into percentage, and marks awarded for Internal Assessment is to be done by the teacher.

It may be noted that if a student could not appear for the Class Test held on the scheduled date due to some valid reason (s) such as Medical/Marriage in the family/Natural Calamities/Family Tragedy/Clash with major Entrance Examination/Any other reason which deems fit, he/she may be given a chance to undertake the Class Test again within a week, on his/her written request to the concerned Teacher or Teachers-in-Charge of the department. Similar chance may be given to the student (s) to submit the Assignment (s) who missed to submit it in time.






