NOTIFICATION

This is for the information of all the concerned that Dr Nirmal Kumar, Associate Professor in the Department of History, has been appointed as a Public Information Officer (PIO) with immediate effect, till further orders, under Section 5(1) of the Central Act of the RTI, to provide public with access of necessary information within the stipulate period. The <u>PIO generally have two key responsibilities:</u>

- Receiving/facilitating requests: Requests are either sent directly to the PIO (or under the Central Act they can also be given to an Assistant PIO (APIO) who forwards it to the PIO). They can be given by hand, mailed by post or even emailed. The Central Act and most State Acts place a responsibility on the PIO to assist applicants to frame their request if they have difficulty writing up the request appropriately or if they are illiterate. The PIO (and APIO) is also responsible for issuing a receipt for the application.
- 2. Responding to requests: The PIO is responsible for processing the request. Generally, this means that they will first need to find all the information requested. This may require them to ask other officers within the organisation to help to find information. They might even need to ask other departments to assist. The PIO will then need to look at the information collected and decide, taking into account the exemptions in the law, whether any or all of the information needs to be withheld from release. The PIO will then notify the applicant of their decision, within set time limits.

It is essential that the PIO understands the operation of the RTI law in detail. It is absolutely essential that the PIO is trained on the law as a matter of priority. He will be the first person responsible for applying the Act to applications, so it is important that he is confident in interpreting and applying the various provisions of the law.

In view of the above, Dr Nirmal Kumar is hereby requested to ensure necessary compliances with the provisions of the act in a time bound manner.





6.1.2.2 Case study showing decentralization and participative management in the College in practice

Case Study: ADMISSION PROCESS

Sri Venkateswara College is a constituent College of the University of Delhi. Admissions to UG courses offered by Sri Venkateswara College are based on guidelines formulated by the University of Delhi (DU). The application process for UG admissions is centralized and is based on merit i.e on the basis of Class XII qualifying examination. Applicants are required to register at University of Delhi Admission Portal. Following registration at DU portal, the college announce cut offs course-wise and category-wise as per the dates notified by the University. The College adheres to the rules and regulations notified by the University.

Admission process at Sri Venkateswara College is a coordinated effort of several academic units and administration. The Admission Committee, comprising of a Convenor and team of faculty members is appointed by Staff Council. The Admission Committee decides the cut-offs of various courses by in consultation with the Principal and Teachers-in- Charge of respective Department. There are many committees constituted that work in coordination with the Admission Committee for an efficient admission process in the College.



Decentralization and Participative Management during Admissions through coordinated efforts of several committees

Committees in the College for UG Admissions

Admission Committee: The Admission Committee forms the Core Committee in the process of admissions in the College. The Core Committee comprises of the Convener, and other members who take lead role in the admission process of students at both UG and PG level. The Committee is responsible for the following –

- 1. To coordinate with University Admission Branch and to provide admission related details like cut off information, number of seats filled, submission of admission reports from time to time.
- 2. To inform about the guidelines and special instructions released by University on day to day basis to Department, TIC and other Committees in the College.
- 3. To manage the Admission Portal and work in coordination with College ICT team and Department TICs/Coordinators.
- 4. To handle and address the queries raised by applicants and parents.
- 5. To verify the documents and approve the admission.
- 6. To coordinate with University for admissions under Ward quota.
- 7. To check and approve applications received by Foreign Students Registry for admission of International students,

Committee at Department Level: Department Teachers-in charge (TIC) /Course Coordinator check the eligibility criteria and calculation of marks for computing the total marks for course-specific combinations. A Combination of "Best Four subjects" for admission in courses through the faculties of Arts, Commerce, Mathematical Sciences, Social Sciences, Applied Social Sciences & Humanities, and "Three Subjects" for admission in courses under Faculty of Sciences and Applied Sciences is taken into consideration for admission to UG courses as per DU guidelines.

Special Categories Admissions Enablement Committee: Committees are constituted in the College to assist applicants belonging to the special categories (SC/ST/OBC/EWS).

Admissions for Persons with Benchmark Disability (PwBD)

A committee is constituted by the College for admissions under Benmark Disabilities. In addition, student volunteers help applicants in filling up application form, guide them to departments and help in payment of fees.

The Committees check the certificates as per the guidelines notified by University of Delhi and recommend for forensic examination of certificates in case required.

Committee for Admissions under Sports and ECA category

Separate Committees are constituted to coordinate admissions under Sports quota and ECA category.

Helpdesk Team

An admission Helpdesk team comprising of faculty and non-teaching staff is constituted during admissions every year. They provide guidance and support to the students who visit the college seeking information about the courses offered by the College, fee structure for each course, number of seats allotted and the admission process. In addition, student volunteers also take active role in providing assistance to aspiring students during admission process. Special teams are assigned to help students with special needs on admission related matters.

Admission Grievance Committee:

In addition, Admission Grievance Committee resolves the admission related grievances posted by applicants and coordinate with University Grievance Committee wherever necessary

Admission Approval Process

Admissions to Under Graduate (UG) courses at the University of Delhi are merit-based and based on cut offs announced course-wise and category –wise by the College as per directions of the University.

All applicants register through the University of Delhi online admissions portal https://ug.du.ac.in.

3-tier Admission Approval Process

Upon declaration of a Cut-Off list by the University, the applicants log in to their Dashboards and choose the course and College in which they wish to claim admission. Colleges are allowed to filter the applicant list as per their cut-off list. This would help in removing the spurious list of applicants. Details of the candidates appear on the Dashboard of the college Course-wise.

The approval process consists of 3 stages -

1. Approval by Department

The Course in-charge/ Teacher in-charge with the assistance of a designated non-teaching staff verify the minimum qualifications/eligibility, cut-off requirement and certificates uploaded by the applicants.

2. Approval by Admission Committee

The Admission Committee alongwith the administrative section of the College check the approved applications received from the Department and Recommend/Not-Recommend the cases for admission.

3. Approval by Principal

The Head of the Institution finally Approve/Decline the admission for cases recommended by the Convenor. For all Declined/Pending cases, remarks are made in the admission portal citing the reason for the same. These remarks are reflected in the dashboard of applicant portal.

Sharing of responsibility by staff, faculty and students as Convenors/members in several committees help in the smooth completion of admissions in the College.
