The procedure for withdrawal of admission and refund of fee is furnished below for information and necessary action

# I) Cancellation/withdrawal of admission within the university schedule for cancellation/withdrawal

- a) The students/applicants who have been admitted provisionally by the university may cancel their provisional admission through the DU portal using their login credentials. For details, please refer to the Delhi University
- b) Refund of the Admission Fee and/or Caution Money will be processed by the **University** to the candidate. The candidates need not to contact the college in this regard.

# [I] Cancellation/withdrawal of admission after the last date of admission as prescribed by the University of

If the provisional admission is to be cancelled/ withdrawn after the period defined by the university, all desirous

- Download the Admission Withdrawal Form and No Dues Form from the college website.
- Submit all the requisite forms dully filled in along with a scanned copy of a cancelled cheque or bank ii. passbook to the office of the Section Officer (Administration) on all working days between 09:30 AM and 12:30 PM for further necessary action in the matter.
- Additionally, all the students of UG/PG courses are required to attach the Admission Cancellation Receipt from the Delhi University Portal alongwith the admission withdrawal form duly completed in all the

It is pertinent to mention here that the office of the Section Officer (Accounts) will process the admissible/ permissible Admission Fee and/or Caution Money/Deposit to the candidate only. This shall be done within 7 working days of successful completion of the requisite admission withdrawal process i.e., post authentication by
