- Withdrawal will be permitted if it is submitted only in writing by the candidate in person with College Identity Card. No withdrawal shall be allowed after 12.00 noon on Friday, the 20th September, 2024.
- Every candidate is required to furnish an affidavit duly completed in all the aspects along with the Nomination Paper to the effect that he/she does not have any previous criminal record and has not been subjected to any disciplinary action by the College/University. Further, the contestants should not have failed in the preceding academic year (s) and/or re-admitted in the current year.
- The last date for receipt of Nomination Paper along with the affidavit duly completed in all the aspects is 19th September, 2024 till 3:00 PM.
