EXPRESSION OF INTEREST TO RUN PHOTOCOPYING & STUDENTS FACILITY CENTRE

Sealed Bids in two bid system i.e. Technical Bid & Financial Bid are invited to run Sri Venkateswara College Photocopying & Students Facility Centre in Sri Venkateswara College, University of Delhi, Delhi – 110021 for the students and the staff. The period of proposed contract will be one year : -

Eligibility:

An Agency/ Firm having an experience of at least 1 year of running Photocopying & Students Facility Centre are eligible to apply. The firm shall have requisite registration certificate for dealing in stationery items.

College invites Sealed Bids in "Two parts" i.e.(Technical and Price Bid) for running Photocopying & Students Facility Centre at Sri Venkateswara College campus for a period **of one years**. The Expression of Interest can be viewed and downloaded from our website www.svc.ac.in. The bids shall have to be submitted duly filled and signed at Sri Venkateswara College. The Bidders who have downloaded the document from website should deposit the Cost of the Form: **Rs 200/- Non- Refundable)** and demand draft of Rs. 5000/- (Rupees five Thousand Only) drawn in favour of "**Principal, Sri Venkateswara College**" payable at Delhi, as the Earnest Money Deposit (EMD) along with Technical Bid. The EMD of Bidders parties, whose Bid are not accepted shall be refunded (without interest) within 30 days of opening of Bids. **The bank details given below:**

The Bids should be submitted in two sealed envelopes one superscribed with "Technical Bid "and other with "Price Bid". Both envelopes shall be put in another sealed envelope superscribing the envelope with "Bid for Photocopy & Students Facility Centre". The last date of submission of bid is **8th May 2023 on or before 05.00 pm**. The Technical bid shall be opened in the presence of attending Bidders or their authorized representatives.

The Bids shall be evaluated on two stage evaluation process. After evaluating the **Technical Bids** the eligible bidders shall be shortlisted for second stage **Price Bids** evaluation. The Price bids of only qualified Bidders after technical evaluation shall be opened subsequently at a notified date in presence of attending Bidders or their authorized representative.

Terms and Conditions For the award of 'Photocopying & Students Facility Centre Contract' for Sri Venkateswara College, University of Delhi, Delhi – 110021.

1. The contract will be awarded on the **basis of highest maintenance charges/ administrative charges (H-1)**. However, **the minimum maintenance charges/ administrative charges should not be less than Rs. 9360/- per month** (@ 12.48 Sq. mtr X Rs 750/-), and will have to give 3000 photocopy free of cost to office/teachers staff. In addition to the payment the electricity charges are extra as per actual electricity consumption.
2. The Licensee has to deposit a sum of **Rs 50,000/-** (Rupees Fifty Thousand only) as a security deposit to the college by NEFT or Demand draft in the name of PRINCIPAL, Sri Venkateswara College Which will be refunded to him at the time of termination of the contract, without any interest. If after signing the agreement, the licensee declines to run the services for any reason of his own, the deposit amount of Rs 50,000/- which he pledges to the college, will be forfeited without any claim or action of any kind, against the college.
3. The licensee should be ensured that the items listed as per Annexure-I shall be available at the Students Facility Centre and rates of the items will be mutually decided by licensee and the Sri Venkateswara College authority. Rates should not be charged more than the prevailing Market Rate/MRP.
4. The licensee should be ensured to install good quality Photocopier Machines, B/W and colour Printer and the rates will be charged as given below:

i) Black & White Photocopy, A4 size paper	– Rs. 1.00
ii) Black & White Photocopy, A3 size paper	– Rs. 1.50
iii) Black & White printing, A4 size paper	– Rs. 5.00
iv) Black & white printing, A3 size paper	- Rs 7.00
v) Colour Printing, A4 size paper	- Rs.10.00
vi) Colour Printing A3 size paper	- Rs.20.00
5. Bids shall be submitted in official bid form only. If submitted in any other form the same shall be summarily rejected. No Bidder shall be issued more than one bid form.
6. Bids received without prescribed Earnest Money Deposit (EMD) shall not be considered.
7. The schedules issued with the form of bid listing the services to be rendered must not be altered by the Bidder. Any modifications/alterations of the schedules considered necessary by the bidder should be in the separate letter accompanying the tender.
8. No paper shall be detached from the bids.
9. The name and address of the bidder shall be clearly written in the space provided and no overwriting corrections, insertion shall be permitted in any part of the bid unless duly countersigned by

the bidder. The bid should be filled in and submitted in strict accordance with the instructions laid down herein otherwise the bids liable to be ignored.

10. The bid is liable to be cancelled if complete information is not given there in or if the particulars and date (if any) asked for in the Schedule to the bid are not filled in.

11. Individual signing the bids and other documents connected with the bid must specify whether he signs as :

(i) A sole proprietor of the concern or constituted attorney of such sole proprietor.

(ii) A partner of the firm if it is a partnership firm, In that case he must have authority to execute contracts on behalf of the firm and refer to arbitration disputes concerning the business of the partnership either by virtue of partnership agreement or by a power of attorney duly executed by the partners of the firms

(iii) Director or Principal Officer duly authorized by the Board of Directors of the company.

(iv) In case of (ii) a copy of the partnership agreement or general power of Attorney, in either case attested by a Notary Public should be furnished or an affidavit on stamp paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney should be furnished. The attested copy of the certificate or registration of firm should be attached along with the bid papers. In case of partnership firm, where no authority to refer dispute concerning the business of the partnership has been conferred on any partner, the bid and all other related documents must be signed by all the partners of the firm. In case of (iii) the person signing the bid should be authorized by a resolution passed by the board of directors and a copy of the resolution attested by the Principal Officer should be attached.

(iv) In case of (ii) a copy of the partnership agreement or general power of Attorney, in either case attested by a Notary Public should be furnished or an affidavit on stamp paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney should be furnished. The attested copy of the certificate or registration of firm should be attached along with the bid papers. In case of partnership firm. Where no authority to refer dispute concerning the business of the partnership has been conferred on any partner, the bid and all other related documents must be signed by all the partners of the firm. In case of (iii) the person signing the bid should be authorized by a resolution passed by the board of directors and a copy of the resolution attested by the Principal Officer should be attached

12. The bid submitted in sealed envelopes mentioned "Bid For Sri Venkateswara College Photocopying & Students Facility Centre" addressed to the Principal, Sri Venkateswara College, University of Delhi, Dhola Kuan New Delhi – 110021 should be submitted at the office of the Principal on or before **8th May 2023** upto 5:00 pm.

13. A demand draft of Rs.5000/- (Rupees Five thousand only) is required to be deposited as a Earnest Money Deposit in favour of "Principal, Sri Venkateswara College" payable at Delhi. The

Earnest Money deposit of the successful bid shall be liable to be forfeited if he does not fulfil any of the following conditions.

(i) An agreement is signed by him in the prescribed form after the receipt of the letter awarding the contract.

(ii) The Photocopying & Students Facility Centre shall commence from the date mentioned in the letter awarding the contract.

14. The bids should be valid in the case of all the Bidders for at least 2 months from the date of opening of the bid and if any bidder withdraws or alters the terms of the bid during the period, the Earnest Money Deposit shall be forfeited. In the case of the successful tenderer, rates quoted shall be valid for the entire period of the contract.

15. Corrections, if any, must be attested.
16. Late Bid will not be considered.
17. Principal, Sri Venkateswara College reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons.
18. The licensees shall be responsible for engaging adequately trained manpower required for providing good photocopier & Stationery Services in the College and arrange payment to the staff engaged as per Labour laws, minimum wages Act. PF, ESI, & Service Tax provisions etc.
19. The employees of the Licensee should possess sound health and be free from any diseases, especially contagious and frequently recurring diseases and they should preferably wear uniform while on duty.
20. The licensee will, prior to the commencement of the operation of contract, make available to Sri Venkateswara College to the particulars of all the employees who will be employed, such particulars inter-alia should include age, date of birth, permanent address and the police verification report for the employees, should be enclosed.
21. The Licensee shall be further responsible for proper discipline for the employees engaged by him and their work besides observing other obligations. No child labourers shall be permitted by Sri Venkateswara College under this contract. Further the licensee shall be responsible to pay all the dues of employees, as well as statutory dues applicable under labour laws. In the event there is any violation of any contractual or statutory obligations regarding the personnel / labour, the licensee shall be responsible and liable for the same. Further, in the event any claim, action or suit is imposed against Sri Venkateswara College, the licensee shall be required to reimburse to Sri Venkateswara College any payment made under such orders or judgments of any competent authority which it may be liable to pay as a Principal Employer as and when such liability is determined. Sri Venkateswara College shall also have the right to deduct these amounts from the payment due to the licensee while settling the payments.
22. The contract shall remain valid up to one year from the date of contract and it may be renewed on mutually acceptable terms and conditions. The contract once awarded can be terminated by either party after giving one month notice to the other party. Nevertheless, Sri Venkateswara College may terminate the contract of the licensee without any notice in case the licensee commits a breach of any of the terms of the contract. Sri Venkateswara College's decision that a breach has occurred will be final and shall be accepted without demur by the licensee.
23. The licensee shall be liable with regard to compliance of all the laws, regulation, rules and directions given by any statutory authority with regard to safety, labor laws or any other laws both Central & State in force. An attested copy of all such statutory registrations shall be enclosed to the tender. The licensee shall comply with all the statutory regulations on control and regulation of piracy issues as revised from time to time.
24. The licensee shall be responsible to maintain the premises of the building, equipment and other articles supplied by the Sri Venkateswara College in good condition. In case of any damage, they shall be responsible to carry out the repairs without any delay to avoid any interruption in service. Cost of repairs shall be borne by the Licensee himself. In case of theft or damage, licensee shall replace items lost, broken or damaged with items of the same quality at his own cost and expense.
25. Sri Venkateswara College shall in no way be responsible for any default with regard to statutory obligation and the licensee will indemnify Sri Venkateswara College in case of any damage, which may arise on account of action of licensee.
26. Service to be provided by licensee are indicated in the Annexure-I attached.

27. Dispute, if any, arising out of the contract shall be settled by mutual discussion or arbitration by sole Arbitrator to be appointed by the Chairman, Sri Venkateswara College at New Delhi as per the provisions of the Indian Arbitration and Conciliation Act, 1996 and the Rules framed there under. Any Arbitrator appointed shall not have the jurisdiction to pass any interim awards, or to grant interest higher than 8% charges simply on the award amounts, or amounts payable to either party.

28. Bid shall be accompanied by the relevant documents including the following :-

- (i) Certificate in support of experience for having undertaken this kind of business along with a list of organizations where the Licensee is currently providing / has provided Students Facility items.
- (ii) Deployment pattern of staff proposed and other details for the efficient satisfactory performance of the contract.
- (iii) Certificates in support of all statutory registrations.

29. The licensee will follow the instructions of designated officers of Sri Venkateswara College and report to him every month to make checks on day to day activities of the services rendered. The licensee shall extend full co-operation to the designated officer from time to time.

30. On termination of the agreement, the licensee will hand over the building, all the equipment's / articles as supplied by the Sri Venkateswara College in good working condition back to College. Care must be taken to ensure while carrying out the work so that no fittings, fixtures, furnishings are damaged. Any damages done to the same or any other property will have to be repaired / replaced by the licensee, failing which the same will be got done at his risk and cost. The decision of the Designated Officer shall be final and binding on the licensee.

31. All work shall be carried out with due regard to the convenience of Sri Venkateswara College. The orders of the concerned authority shall be strictly observed.

32. The licensee will work in closed co-operation and co-ordination with other agencies working at site.

33. The licensee has to deploy adequate number of staff who has to work during holidays, late hours and Sundays as well according to the requirement and convenience of Sri Venkateswara College and the occupants, while ensuring weekly offs of his / her employees as per statutory requirements.

34. The licensee shall be fully responsible about the conduct of his employees and shall ensure that their behaviour with the students, residents, supervisors, officers is always good and cordial. If it is found that the conduct or efficiency of any person employed by the licensee is unsatisfactory, the licensee shall have to remove the person concerned and engage a new one within (48) hours of intimation. The decision of the Designated Officer in this regards shall be final and binding on the licensee.

35. Sri Venkateswara College is not bound to provide any mode of transport in respect of men or material required for the contract.

36. The licensee shall at all times indemnify and keep indemnified the Principal Employer, the Head of the Officer and its officers, servants and agents for and against all third party claims whatsoever, including time, not limited to property loss and damage, personal accident, injury or death of / or property or person of any sub-contract and or the servants or agents of the licensee any sub-licensee(s) and or the owner and the contractor shall at his own cost and initiative at all times, maintain all liabilities under workman's Compensation Act/ Fatal Accident Act, Personal Injuries, Employees State Insurance Act, PF Act and / or their Industrial Legislation from time to time in force.

37. The payment towards supply of Office stationery items to Office and Academic Stationery to Academic Departments shall be released on monthly basis after satisfactory completion of the job and for the work actually done on submission of the statement indicating department wise amount. The original

requisition Slip duly signed by Head of Depts. should also be attached with the bill. Income Tax (TDS), as applicable at prevailing rate will be deducted at source.

38. The licensee shall deposit Rs.50,000/- (Rupees fifty thousand Only) as Security Deposit with Sri Venkateswara College. No interest shall accrue on this deposit, which will be returned after the successful completion of contract and after adjusting dues if any, of the licensee to Sri Venkateswara College. The EMD of successful bid will be converted as security deposit and the EMD of unsuccessful Bidder will be refunded.

39. The workmen employed by the licensee shall be directly supervised and controlled by the licensee, and shall have no relation whatsoever with Sri Venkateswara College. The college shall have no power to control or supervise such workmen or to take any action against them except as permissible under law. Such workmen shall also not have any claim against college for service or legalization of services by virtue of being employed at the college against any temporary or permanent posts at the college.

40. The work executed shall be to the satisfaction of designated officers of the Sri Venkateswara College, Delhi.

41. The licensee shall ensure that either he himself or his representative is available for proper Administration and supervision at the works.

SERVICES TO BE PROVIDED BY SRI VENKATESWARA COLLEGE PHOTOCOPYING & STUDENTS FACILITY CENTRE

During continuance of the Contract of Photocopying & Students Facility Centre the agency, licensee shall take over the responsibility for providing all the stationery items (As per enclosed Annexure-I) and photocopy Service.

The scope of service to be rendered under this agreement includes the following:

1. To sell the Office, Academic and Students stationery by making his own investment and stock and sell all items relating to stationery supply as per the requirement of Sri Venkateswara College authorities and students specified from time to time.
2. To provide the students Facility items and services to Sri Venkateswara College and students at competitive rates. This shall not be more than the MRP and Market Rate.
3. To upgrade the service as per the technological developments taking place in the areas of computer hardware, Xeroxing, binding, etc.
4. To provide access to the committee constituted by Sri Venkateswara College centre for monitoring the quality, specification and rates and act as per the advice and instructions of the said committee / management of Sri Venkateswara College.
5. To display rates of all major items and photocopy charges in the students facility centre.
6. The contactor shall be responsible to ensure the conduct and behaviour of the persons employed by them for running the centre.

7. The payment for the monthly bills towards supply of Office and Academic and Students Stationery (As per Annexure-I) shall be supported by authorization for supply of such services and will be settled within a month of submitting the bills in duplicate. TDS will be deducted as per Income Tax Rules in force.
 8. The licensee is required to obtain all local licenses for running the photocopy & students facility centre as per the requirement of statute in force and revise from time to time.
 9. The licensee shall indemnify Sri Venkateswara College against any liability towards non-compliance of any of the statutory obligations required to be fulfilled while operating such service in the premises of Sri Venkateswara College.
 10. The licensee shall disburse wages to the staff deployed in the photocopying & students facility centre as per the prevalent minimum wages Act besides fulfilling all other statutory obligations of PF, ESI Service Tax etc.
 11. To ensure security of moveable and immovable property of Sri Venkateswara College premises handed over against theft or damage.
 12. Subletting of contract shall not be permitted.
 13. The B&W machine, shall be of reputed brands like Modi, Xerox, Canon, Godrej having latest configuration and not older than one year.
 14. Sri Venkateswara College administration & students shall have freedom to procure stationery items from open market.
 15. Sri Venkateswara College will not be responsible to provide any residential accommodation to personnel deployed by the licensee.
