Term of the student members/representatives to the ICC

Under regular circumstances, the term of the Students Representative to the ICC is **for a period of one year starting w.e.f. 18th February, 2026 to 17th February, 2027** or till the result of the subsequent election is declared in the category or till they are the bonafide student(s) of that course for which they were admitted, whichever is earlier, provided that

1. The students' representatives shall not represent in the ICC from the end of their examination (in May) till the commencement of the subsequent academic session; and
2. The Students' Representatives to the ICC shall, in no case, have a term beyond one year.
3. The members appointed from amongst the non-government organizations or associations shall be paid such fee or allowances for holding the proceedings of the Internal Committee, by the Executive Authority as may be prescribed.
