We respectfully request your kind consideration for the establishment of an official chapter of the **International Finance Student Association (IFSA)** at Sri Venkateswara College.



Its core mission is to foster leadership, professionalism, and financial expertise among students through international case competitions, trading simulations, skill-building workshops, and industry collaborations.


The establishment of a chapter at our college would:
